

Annual Pass benefits include:

- ✓ unlimited visits all year during opening hours
- ✓ Free admittance to Airfield festivals and drop-in workshops
- ✓ Discount on food from Overends Kitchen
- ✓ Discounts on selected courses/events
- ✓ Preferential booking on popular events such as The Christmas Experience

Some little T&C's to help you get the most out of your annual pass.

- ✓ We're open 12 months of the year but there may be times we need to close for maintenance, weather and private events or to just enjoy a well-earned holiday. We try to keep these to a minimum and you'll be notified well in advance via email of any scheduled closures
- ✓ You're welcome to visit the Estate as often as you like during opening hours. Last admission is 30 minutes before closing time. As example, if the Estate closes at 5pm, you're welcome to come in up until 4.30pm
- ✓ Annual Pass cards, benefits and discounts are non-transferrable
- ✓ We're required to take a picture of the main pass holder (adult) associated to your Annual Pass and this will be printed onto your card
- ✓ If you need a replacement card, we can issue at the cost of €10
- ✓ We'll send you regular emails for special events, Airfield news and discounts. You can opt out at any time, however if you do opt out, note you may miss out on discounts and pass holder benefits
- ✓ Discount on food purchased in Overends Kitchen is applied when you present your annual pass card at the till Discount is only available to pass holders, not nominated friends or family
- ✓ Children under 16 should always be accompanied on the Estate
- ✓ Car parking at Airfield is limited and is offered on a first-come, first-served basis. It is not guaranteed with your annual pass
- ✓ An Annual Pass cannot be used in conjunction with any other promotion
- ✓ Airfield Estate reserves the right to change benefits and terms at any time without notice
- ✓ Airfield Estate reserves the right to cancel an annual pass at any time
- ✓ Information will be collected in accordance with Data Privacy Rules

Nominated Adults (not applicable to Individual, Senior or Joint Pass accounts)

- ✓ Group Passes (i.e. 3 Persons upwards) can nominate one named adult on the pass who can visit in place of the pass holders not in addition too, known as the nominated adult
- ✓ It is your responsibility as a pass holder to inform the nominated adult of the T&C
- ✓ Nominated adults are not pass holders, they are a benefit of an annual pass holder
- ✓ Nominated adults will not be issued a card, they can gain free entry in place of the named adults on the pass. For the nominated adults to gain entry they must present themselves at the Ticket Kiosk
- ✓ Nominated adults are not permitted to use the pass holder's cards
- ✓ Annual Pass benefits only apply to the named pass holders not the nominated adults or guests

What does your annual pass cover?

Individual Pass:

- 1 named pass holder

Senior Pass:

- 2 named senior pass holders *or*
- 1 Senior Pass holder and guest

2 Person Joint Pass:

- 2 named pass holders *or*
- 1 named pass holder and guest

Group Passes

3 Person Pass:

- 2 named pass holders and 1 guest *or*
- 1 named pass holder and up to 2 guests

4 Person Pass:

- 2 named pass holders and up to 2 guests *or*
- 1 named pass holder and up to 3 guests

5 Person Pass:

- 2 named pass holders and up to 3 guests *or*
- 1 named pass holder and up to 4 guests

6 Person Pass:

- 2 named pass holders and up to 4 guests *or*
- 1 named pass holder and up to 5 guests
