**Terms and Conditions:**

- We're open 12 months of the year however this is subject to change and we will keep closures to a minimum. Please check our website for the latest information on our opening days/hours, and we encourage you to join our e-newsletter for updates.
- Correspondence with annual pass holders will be via e-mail.
- You're welcome to visit the Estate as often as you like during opening times up until last admission. Current opening hours can be found on our website [www.airfield.ie](http://www.airfield.ie)
- Annual Pass cards, benefits and discounts are non-transferrable.
- We're required to take a picture of the main pass holder (adult) associated to your Annual Pass and this will be printed onto your card.
- If you need a replacement card, we can issue at the cost of €10.
- If you opt in to emails, we'll send you regular emails for special events, Airfield news and discounts. You can opt out at any time, however if you do opt out, note you may miss out on discounts and pass holder benefits
- Children under 16 should always be accompanied and supervised by an adult on the Estate.
- Car parking at Airfield is limited and is offered on a first-come, first-served basis. It is not guaranteed with your annual pass.
- An Annual Pass cannot be used in conjunction with any other promotion.
- Airfield Estate reserves the right to change benefits and terms at any time without notice.
- Airfield Estate reserves the right to cancel an annual pass at any time
- Information will be collected in accordance with Data Privacy Rules
- Unfortunately, non-compliant visitors will leave us with no other option but to request you leave the estate in the interests of public health. Please understand that this for your safety as much as our staff and other guests

### Nominated Adults (not applicable to Individual, 1 Person, 2 Senior or 2 Person Pass accounts)

- Group Passes (i.e. 3 Person Pass and upwards) can nominate one named adult on the pass who can visit in place of the pass holders not in addition too, known as the nominated adult.
- The nominated adult is an additional benefit to the account to allow for a child minder to visit the estate in place of the named card holders.
- It is your responsibility as a pass holder to inform the nominated adult of the T&Cs.
- The nominated adult is not pass holder, they are a benefit of an annual pass holder account.
- The nominated adult will not be issued a card, they can gain free entry in place of the named adults on the pass. For the nominated adult to gain entry they must present themselves at the Ticket Kiosk.
- The nominated adult may not bring adult guests into the estate on the pass, they can visit on their own or with children the pass would cover.
- Nominated adults are not permitted to use the pass holder's cards.
- Annual Pass benefits only apply to the named pass holders not the nominated adults or guests.

### What does your annual pass cover on any given day?

- 1 Person Pass: Allows access for 1 named Pass holder.
- 2 Senior Person Pass: Allows access for 2 named Pass holders or 1 named pass holder and 1 guest.
- 2 Person Pass: Allows access for 2 named Pass holders or 1 named pass holder and 1 guest.
- 3 Person Pass: Allows access for 2 named Pass holders & 1 guest or 1 named pass holder and 2 guests.
- 4 Person Pass: Allows access for 2 named Pass holders & 2 guests or 1 named pass holder and 3 guests.
- 5 Person Pass: Allows access for 2 named Pass holders & 3 guest or 1 named pass holder and 4 guests.
- 6 Person Pass: Allows access for 2 named Pass holders & 4 guests or 1 named pass holder and 5 guests.

NOTE: A person or guest is an adult or child over the age of 4 yrs. Children aged 3 years and under are free.
